Candidate Eligibility

Te Kāhui o Taranaki Trust

B - NOMINATORS to fill out

Rules 2.1 and 6.7 of the Second Schedule to Te Kāhui o Taranaki Trust Charter provides that nominees must, as at the closing date for nominations, be recorded in the Taranaki Iwi Register as an Adult Registered Member of Taranaki Iwi and shall not be eligible for nomination as a candidate for election as Trustee if he or she:

- (a) is bankrupt or has within the last five (5) years been adjudged bankrupt or has made any composition or arrangement with his or her creditors;
- (b) is or has ever been convicted of an offence involving dishonesty as defined in section 2(1) of the Crimes Act 1961, or an offence under section 373(4) of the Companies Act 1993 (unless that person is an eligible individual for the purposes of the Criminal Records (Clean Slate) Act 2004);
- (c) is or has been convicted of an indictable offence (unless that person is an eligible individual for the purposes of the Criminal Records (Clean Slate) Act 2004);
- (d) is or has ever been disqualified from being a director of a company registered under the Companies Act 1955 or the Companies Act 1993;
- (e) is or has ever been removed as a trustee of a trust by order of Court on the grounds on breach of trust, lack of competence or failure to carry out the duties of a trustee satisfactorily;
- (f) is subject to a compulsory treatment order under the Mental Health (Compulsory Treatment and Assessment) Act 1992 or is subject to a care and protection order under the Protection of Personal and Property Rights Act 1988; or
- (g) is physically or mentally incapacitated to the extent that he or she is unable to perform the duties of a Trustee;
- (h) is subject to a property order made under section 30 or 31 of the Protection of Personal Property Rights Act 1988;
- (i) has, within the last three (3) years, been removed from the office of Trustee in accordance with rule 1.3 of the Eighth Schedule.
